

AS ALWAYS, THE HOUSE PROVIDES FREE PARKING FOR FAMILIES, AND PARTNERED WITH UNC TO PROVIDE FREE SHUTTLE SERVICE TO THE HOSPITAL THROUGHOUT THE PANDEMIC.

THE HOUSE IS IN ITS 11TH YEAR OF OPERATING A RONALD MCDONALD HOUSE FAMILY ROOM, LOCATED ON THE 7TH FLOOR OF UNC CHILDREN'S HOSPITAL. ANY INPATIENT FAMILY OF PEDIATRIC PATIENTS (INCLUDING THOSE NOT STAYING AT THE HOUSE) ARE WELCOME TO VISIT THE FAMILY ROOM WHICH PROVIDES RESPITE AWAY FROM THE CLINICAL HOSPITAL ATMOSPHERE. THE ROOM FEATURES A COMFORTABLE LIVING ROOM AND A FULLY STOCKED EAT-IN KITCHEN. THE ROOM IS ALSO STOCKED WITH BOOKS AND TOYS. UNDER NORMAL CIRCUMSTANCES, THREE CATERED MEALS AND FRESH-BAKED COOKIES ARE PROVIDED WEEKLY. IN THE 21/2 MONTHS PRIOR TO THE CLOSURE OF THE FAMILY ROOM, WE SERVED 535 UNIQUE VISITORS.

THE FAMILY ROOM CLOSED IN MARCH OF 2020 AND REMAINED CLOSED FOR THE BALANCE OF THE YEAR. THE RMH STAFF TURNED THEIR FOCUS TO PROVIDE

SUPPORT TO FAMILIES WITH PATIENTS AT UNC CHILDREN'S WHO WERE NOT NECESSARILY ASSOCIATED WITH THE HOUSE. FOOD INSECURITY QUICKLY BECAME AN ISSUE WITH MOST HOSPITAL FOOD RESOURCES SHUT DOWN DUE TO COVID. STORIES BEGAN TO EMERGE OF PARENTS EATING THE FOOD THAT WAS INTENDED FOR PATIENTS. WE PIVOTED OUR FOCUS AND BEGAN FREQUENT TRIPS TO THE HOSPITAL, MEETING HOSPITAL STAFF IN THE PARKING LOT TO HAND OFF FOOD AND DRINK THAT NORMALLY WOULD HAVE BEEN AVAILABLE IN THE FAMILY ROOM. THESE ITEMS WERE THEN MADE AVAILABLE TO FAMILIES AT THE NURSES' STATIONS.

ADDITIONALLY, WE CONTINUED TO SUPPLY SUPPORT TO THE UNC REX INFUSION CLINIC IN RALEIGH, KEEPING THEM STOCKED WITH SNACKS AND DRINKS FOR CHILDREN RECEIVING CARE THERE.
