**WHILE OUR DOORS REMAINED OPEN TO FAMILIES OF SERIOUSLY ILL CHILDREN IN 2020, THE WAY WE PROVIDED SERVICES WAS SIGNIFICANTLY ALTERED DUE TO THE PANDEMIC. OUR RESIDENTIAL PROGRAMS IN DURHAM AND RALEIGH PROVIDED 6,080 NIGHTS OF HOSPITALITY FOR 321 FAMILIES, INCLUDING 9 MONTHS OF VISITS RESTRICTED TO FAMILIES WITH THE SICKEST OF CHILDREN. DESPITE THE CHALLENGES FACED IN 2020, OUR RONALD MCDONALD HOUSE PROGRAMS WELCOMED FAMILIES FROM 64 NC COUNTIES AND 17 OTHER STATES. HOSPITALS WERE ALSO MADE AVAILABLE TO SUPPORT HEALTHCARE WORKERS, RMH  
STAFF CHANGED OUR SERVICE MODEL IN ORDER TO CONTINUE PROVIDING FAMILIES  
OF PEDIATRIC PATIENTS WITH THE SUPPORT THEY NEEDED. WITH THE HELP OF  
PEDIATRIC NURSING STAFF, MATERIAL SUPPORT SUCH AS TOILETRIES AND FOOD  
WAS DELIVERED DIRECTLY TO CAREGIVERS AT THEIR CHILD'S HOSPITAL BEDSIDE.
